Sub: **Regarding Mentors at schools for implementation of NIPUN AXOM.**

Sir/Madam,

You are aware that the Education Department of Government of Assam has undertaken the Foundational Literacy and Numeracy Mission in the name of **NIPUN AXOM** based on the National Initiative for Proficiency in Reading with Understanding and Numeracy (NIPUN Bharat). For successful implementation of the said mission, the role of teachers is very important. For capacity building of the teachers in the mission, mentors are to be engaged in every school having class-1 to 5 (including composite schools where class-1 to 5 is available).

The mentors will be faculty from higher institutions, DIET faculty, faculty from BTC, Expert members of DACG and BACG, faculty from PPTC, Expert BRPs, Expert CTCCs, Expert teachers (including retired) from Secondary and Higher Secondary Schools, retired educationists etc.

Number of schools to be allotted for School Mentors:

- Minimum 5 schools including AWCs for each School Mentor

Role and responsibilities of Mentors:

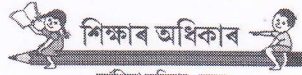
- Will maintain the database of the allotted schools along with AWCs (if allotted)
- Will visit the allotted schools along with AWCs (if allotted), minimum once in a week.
- Will orient the teachers of allotted schools and AWCs (if allotted) as and when required/planned by district/block/clusters.
- Will provide hand-holding academic support to teachers on necessary pedagogical support.

Role and responsibilities of DMO, BMO, DIET, BTC, Normal Schools etc. :

- District Mission Coordinator will communicate with all concerned i.e DIET, BTC, Normal Schools, PPTC, BMC, DACG & BACG members, CRG etc. regarding engagement of mentors in each of the schools where **Foundation Literacy and Numeracy Mission (NIPUN AXOM) has been planned to implement.**
- Block Mission Coordinator will prepare the list of Mentors and will issue the notification.
- Block Mission Coordinator will sit with the Principals (DIET, BTC, Normal Schools, PPTC etc.) and will prepare the list of mentors allotting schools. After this, notification will be issued by the head of the concerned institution. A copy of the same will be submitted to the Block Mission Office and District Mission Office.
- DMO, BMO will organize orientation programme for the School Mentors from time to time.
- DMO, DIET, BMO etc. will monitor the activities of School Mentors.
