Sub: Regarding 1-day Monthly Cluster Meeting on the implementation of NIPUN AXOM MISSION (FLN).

You must be aware that NIPUN AXOM MISSION (FLN) has been launched in Assam by Honourable Chief Minister on 16th November, 2021. Under this Mission, it is expected that every child achieves the desired Learning Outcomes in reading, writing and numeracy at the end of Grade-3 by 2026-27.


It is needless to reiterate that as front-line activists for proper and effective implementation of the mission activities in schools, the teachers must be well acquainted with the fundamental principles and detailed guidelines of the programme.

Hence, for bringing more awareness and building ownership, developing professional capacity amongst the teachers and the smooth implementation of the mission, you are requested to conduct 1-day monthly cluster meeting on regular basis w.e.f the month of September, 2022 without fail as per the guidelines/norms given below:

- Assistant Teachers and Head Teachers of all Govt. and Provincialized schools having class-I to V (including Composite Schools) will be invited.
- The meeting will be held in the Head Quarter School of the cluster.
- Concerned Cluster Resource Centre Coordinators (CRCCs) will inform the date and time of the meeting with formal communication with the support of Block Mission Office.
- Purely academic areas/issues related to NIPUN AXOM MISSION (FLN) will be discussed in the meeting.
- DIET faculties/Instructors of BTC and Normal Schools/BRPs/DPOs/CRCCs and Expert Teachers will act as Resource Persons in the meeting.
- Each session of the meeting will be conducted as per agenda. The Resource Persons can prepare the resource materials/supporting documents related to the areas of the agenda of the meeting.
- The agenda of the meeting prepared by State Resource Group of NIPUN AXOM MISSION (FLN) is enclosed herewith along with the supporting documents (Annexure-I & II).
- Each participant must be provided a photo copy of supporting documents and the same to be shared in whatsapp group.
- The required number/ quantity of materials for each venue, such as – Textbook, marker pens, flip charts, paper clips, etc. are to be kept ready well in advance in the meeting venue by the concerned Cluster Resource Centre Coordinators (CRCCs).
- The monitoring must be done by BRG, DRG members, DPOs (all), DIET faculties etc.
- The programme must be properly documented. A detailed report of the entire programme is to be submitted at the State Mission Office after completion of the training programme.
- Each BEEO/BMC will ensure the participation of teachers in the meeting every month. Concerned BEEO/BMC will take necessary action for the teachers who are absent in the meeting.
- An assessment is to be done for the participants at the end of the meeting.
